Our office staff are constantly working to help our residents on many fronts, whether it's helping with seniors filing for Medicare, or Liheap, to working with other organizations for the use of our hall for meetings and other functions. We also provide handicap placards and loan medical equipment when needed. We're here to help you, even if it's just helping someone figure out their cellphone. Did you know that we also have several notaries on staff for when you have those important documents to sign, and that there is no charge for this service.

Our Senior Transportation service has also been busy with providing over 3,000 rides for seniors, 60 and older, including those with disabilities in 2023. We provide rides to doctor appointments, picking up prescriptions, grocery shopping as well as beauty shop appointments and also offer several special events throughout the year. We also continue to work with the Veterans Assistance Commission of Lake County. If you are a veteran, or you know of a veteran that needs assistance please let us know and we'll help. Our program is specifically designed to help area active adults aged 60 and older with their transportation needs. Getting to doctors, beauty appointments and grocery shopping has never been so easy!



#### **SENIOR BENEFITS PROGRAMS**

Wauconda Township assists people, 65 and older, and people with disabilities to apply for the Benefits Access Program. This application provides a significant discount on the license plate sticker (one vehicle per household) and first time applicants for the RTA free ride pass. Income limits are as follows: Total 2023 Gross Income must be less than –

- \$33,562 for a 1 person household
- \$44,533 for a 2 person household
- \$55,500 for a 3 person household

SHIP help (Senior Health Insurance Program) is available –Wauconda Township offers help to navigate Social Security, Medicare, and Medicaid options. Reminder: Medicare Open Enrollment begins October 15 and continues until December 7 each year. This is the opportunity to change your Medicare Part D or Medicare Advantage plan. Medicare advises that you do not have to change your plan but it is always wise to look at changes that may affect your coverage.

The township maintains a medical equipment lending closet. Wheelchairs, walkers, rollators, shower chairs, transfer benches, commodes, toilet risers, canes and bed rails are taken as donations and lent at no charge to people recovering from surgeries or injuries. These items may be borrowed for the duration of recovery or until clients receive a Medicare covered replacement.

#### **FROM THE ASSESSOR'S OFFICE**



#### **WELCOME SPRING!**

Starting this year, the Chief County Assessment Office for Lake County has installed a deadline of July 31st to file exemptions you would have qualified for in the previous year! What does this mean, you ask? This is in reference to any exemptions you may be qualified for that should be reflected on the Lake County Property Tax bills for Tax Year 2023 payable in 2024 that will soon be mailed the 1st week of May. For example, did you or your spouse turn 65 years old in 2023 and you didn't apply for the Senior Homestead exemption? Or did you forget to apply for the renewal of the Disabled Person, Disabled Veteran, or the Low-Income Senior Freeze exemptions

in 2023? This is a *HARD DEADLINE* and failure to file by July 31st, 2024, will result in a loss of tax savings of those exemptions for that year. Please contact our office as soon as possible if you have any questions regarding eligibility.

Please keep in mind for those with the Disabled Person, Disabled Veteran & Low-Income Senior Freeze exemptions that these exemptions need to be renewed every year. If you have not done so for Tax Year 2024, please take a moment to complete the application online or come to our office with the necessary paperwork and we can assist with the application process.

At the conclusion of 2023, our Township saw a 33% *decline* in the number of sales as compared to 2022. Despite that, the Township saw an *increase* in sale prices. The median sales price in 2022 was \$272,500 and the median sales price in 2023 was \$285,100 which is a *4.6% increase year over year*. This followed a 9% increase from 2021 to 2022. How does this affect you; you might wonder? The rapid increase in sales prices from year to year will likely affect the value of your home. As sale prices increase, it is necessary for values to increase along with it. This is reflected with positive equalization factors. If values from the previous year deviate too far from the market trends, it is possible that a larger than average equalization factor will need to be applied to bring values nearer to what is reflected in the market. We expect this to be the case for the next several years.

We anticipate the 2024 Assessment notices to be in the mail by the end of July/early August.

FREE mulch will be available at the Road District building now through October while supplies last.

#### Unincorporated Wauconda Township Residents Only BRUSH PICK UP WILL START MAY 13, 2024

To increase the efficiency of our department, brush pickup will only be done on the second Monday of each month, May – October.



- Brush should be placed in the right of way no later than 7 am on the day of pickup as our equipment will only make one pass through all neighborhoods.
- All cut ends need to be facing the same direction towards the street.
- Please do not allow brush to extend into the street.
  - No metal, garbage, weeds, leaves or yard waste will be picked up.
- Brush may not be brought to Township for disposal.
- Storm damage will be dealt with on a case-by-case basis.
