

**WAUCONDA TOWNSHIP  
REGULAR BOARD MEETING  
February 20, 2019**

**Call to Order:** Supervisor Swanson called the meeting to order at 6:03 p.m. with the Pledge of Allegiance.

**Roll Call:** Clerk Rowe proceeded with roll call. Answering present was: Trustee McKernan, Trustee Stiller and Supervisor Swanson. **Approve Agenda:** Trustee Stiller motioned and Trustee McKernan seconded to approve the agenda. Voice roll call was taken. All were in favor. Motion passed.

**Approve Minutes: January 16, 2018 Regular Board Meeting**

Trustee Stiller motioned and Trustee McKernan seconded to approve the minutes. A voice roll call was taken. All were in favor. This motion carried.

**Approve Payment of General Town Fund Bills: January 17, 2019 to February 20, 2019:**

Trustee McKernan motioned and Trustee Stiller seconded to approve the payment of the General Town Fund bills. After some questions regarding some expenses by Trustee Stiller, a voice roll call was taken. All were in favor. This motion carried.

**Approve Payment of Road District Fund Bills: January 17, 2019 thru February 20, 2019:**

Trustee Stiller motioned and Trustee McKernan seconded to approve the payment of the Road District bills. Highway Commissioner asked that a deposit of \$7800.00 for a new truck be included in the bill payments. By ordering now and putting down the deposit, there is a large savings, plus the truck would be delivered in time for next winter. Highway Commissioner stated he has applied for a grant to cover the cost of the truck. The motion was amended to include the deposit. A voice roll call was taken. All were in favor. This motion carried.
